


**Severability/Savings Clause**

This Agreement is subject to the law as it currently exists or is hereafter amended. If any term or provision of this Agreement is, at any time during the life of this Agreement, adjudged by a court or administrative body of competent jurisdiction to be in conflict with any law, such term or provision will become invalid and unenforceable, but all of the remaining provisions of the Agreement that are not rendered meaningless, inoperable or ambiguous as a consequence of the court's or administrative body's ruling shall remain in full force and effect. ~~such invalidity or unenforceability will not impair or affect any other term or provision of this Agreement.~~ The parties shall meet as soon as practicable to negotiate in good faith with respect to the effects any term or provision of this Agreement found to be in contravention of the law.
